During this training period they have to attend the class regularly, complete the project Related to fashion designing & submit the report within a given period of training.

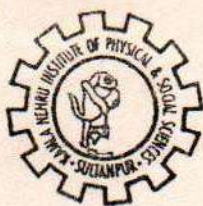
